Q2 2020 Internet Industry Overview

- There were 17 reported Internet M&A transactions in Q2 2020, representing more than \$7.6B in transaction value
 - Internet M&A deal volume in Q2 2020 was down 46.9% relative to Q2 2019, which saw 32 transactions
 - Notable deals include:
 - Just Eat Takeaway.com's acquisition of Grubhub, an online takeout food platform for diners and restaurants, for \$6.7B, representing 5.0x LTM Revenue
 - Forge Global's acquisition of SharesPost, an online financial marketplace designed to offer more transparent access to private markets, for \$160M
 - Chegg's acquisition of Mathway, an online equation solver and math tutoring solution, for \$115M, representing
 8.8x LTM Revenue
- The Internet IPO market saw three major IPO pricings in Q2 2020:
 - SelectQuote, an insurance lead generation platform, raised \$570M on May 21st and traded up 27% through the end of the quarter
 - Dada-JD Daojia, an on-demand logistics and omni-channel ecommerce platform in China, raised \$320M on June 5th and traded up 39% through the end of the quarter
 - Vroom, an online ecommerce platform for the buying and selling of used vehicles, raised \$468M on June 9th and traded
 up 137% through the end of the quarter
 - DraftKings, a digital sports and gaming company, raised \$1.6B on June 22nd and traded down 17% through the end of the quarter
